

Winter Offers - Terms & Conditions

These terms and conditions should be read in conjunction with Otium terms and conditions.

- 1. All services are subject to availability and payment must be made in full in advance of the service.
- 2. All vessels and owners are required to comply with the Marina Regulations of the individual marina.
- 3. These offers are available to Otium Rewards members only and no other offers can be used in conjunction with these offers.
- 4. Marina Developments Limited reserves the right to withdraw these offers at any time.

Winter Berthing – Buy 1 Month and get 1 Month Free Offer

- 1. The bonus points offer starts on 1st October 2021 and ends on 31st December 2021.
- 2. Points allocated to your account under this promotion may only be redeemed against winter berthing before 31st March 2022.
- 3. You will be invoiced for the entire duration of your stay at the time of booking, your points will be allocated as a discount against 50% of your stay. For example, if you stay for 2 months you will be invoiced for 2 months in advance and pay the value of one month's berthing.
- 4. Bonus points will be applied to the Monthly Berthing rate for pontoon and Dry Stack berthing at the following MDL Marinas: Shamrock Quay, Ocean Village, Northney, Sparkes, Hythe Marina Village, Chatham Maritime, Penton Hook, Port Hamble, Hamble Point, Saxon Wharf and Queen Anne's Battery marinas. - 5. For every month's berthing paid for in advance during the offer period (up to a maximum of three months), points will be awarded at a rate of 100% on subsequent monthly berthing e.g., pay £1,000 and earn 1,000 bonus points. 1 point equals £1. Points allocated to your account under this offer may not be used in conjunction with any other offer or held for future other services at MDL Marinas.
- 6. One car parking permit will be issued at the marina the boat is kept at during this offer period.
- 7. The offer does not include electricity. If electric is required, then a metered lead will need to be purchased and then usage charged at the actual rate plus admin fee and is not transferable.
- 8. No pro rata refunds given. For cancellations part way through the contract, charging will revert to the standard overnight rate.
- 9. Owners may be asked to move to an alternative mooring if the berth is subsequently sold to an annual customer.
- 10. At Ocean Village Marina the offer is for boats under 9m LOA.
- 11. At Hamble Point Marina the offer is for boats up to 10m LOA only.

Winter Boatyard Double Points Offer

- 1. The double points offer starts on 1st October 2021 and ends on 31st December 2021.
- Double points will be applied to the following MDL boatyard services: Lift, block, or load onto transport | Lift, hold, relaunch | Relaunch/launch off transport | Haul out and relaunch | Tractor & Driver launch and recover – slipway | Lift, wash, and relaunch | Contract craning – use of apron | Extended period in slings | Emergency lift.
- 3. The offer is available at the following MDL boatyards Shamrock Quay, Northney, Hythe Marina Village, Chatham Maritime, Saxon Wharf and Hamble Point marinas.
- 4. At Hamble Point Marina the offer is for boats up to 10m LOA only.
- 5. For boatyard services listed above and paid in advance during the offer period, points will be awarded at 28% for Otium Rewards members (visitors).
