## Location

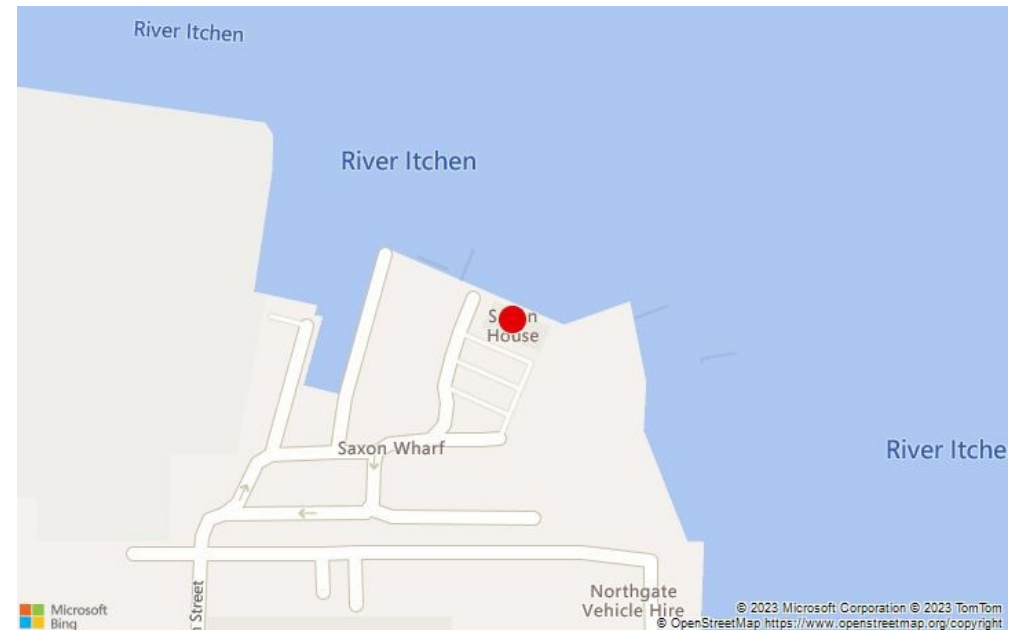
